### **Update on Southern Africa situation**

## Air France – KLM flights to/from Johannesburg and Cape Town

As a result of the travel restrictions imposed by authorities to travellers from Southern African countries due to the COVID-19 Omicron variant, please find below an overview of all current flights of Air France -KLM, operating to/from South Africa as well as the latest entry regulations to France and the Netherlands.

### **Air France**

### Johannesburg, with effect 04 December 2021

### **Entry requirements for France**

New regulations have been issued by the French government, which became effective on the 4<sup>th</sup> of December 2021. South Africa has been placed on the 'Scarlet Red' country list. The entry and exit regulations for France are listed in the table below. Passengers in transit in France must check all entry/exit regulations for their final destination country at <a href="https://www.airfrance.traveldoc.aero">www.airfrance.traveldoc.aero</a>.

	Proof of vaccination	Compelling reason to travel	Test required before boarding first flight	Test required on arrival	Quarantine on arrival
Travel TO South Africa	With or without proof of vaccination	Permission to exit France is subject to the list of compelling reasons of 'Scarlet Red' countries applicable to the country of destination. This does not apply to passengers in transit via France.	Passengers aged 5 years and older travelling to or transiting via South Africa must hold a negative PCR test < 72h prior to arrival. They must also complete a health form.	Not required for South Africa (No <u>additional</u> test will be done on arrival)	Not required for South Africa.
Travel FROM South Africa	With or without proof of vaccination	Subject to the list of compelling reasons of 'Scarlet Red' countries to enter France. This does not apply to passengers in transit via France.	All passengers must be in possession of: A negative PCR test < 48h before boarding the first flight <b>OR</b> a negative antigen < 24h before boarding the first flight. This does not apply to passengers in transit via France	Systematic PCR or Antigen test on arrival in France	Mandatory 10- day quarantine monitored by the Authorities.

## **Entry requirements for the Netherlands**

The entry requirements are listed below. Passengers in transit in the Netherlands must check all entry/exit regulations for their final destination country at <a href="https://www.klm.traveldoc.aero">www.klm.traveldoc.aero</a>.

	Proof of vaccination	Eligible passengers for entry/exit	Test required before boarding first flight	Test required on arrival	Quarantine on arrival
Travel TO South Africa	With or without proof of vaccination	All passengers may travel to or transit via South Africa	Not required for South Africa.	Passengers aged 5 years and older travelling to or transiting via South Africa must hold a negative PCR test < 72h prior to arrival. They must also complete a health form.	Not required for South Africa.
Travel FROM South Africa	With or without proof of vaccination	The following passengers may travel to or transit via the Netherlands:  - Dutch nationals Foreign nationals who are resident in the Netherlands - EU residents and residents of Schengen countries if travelling to their country of residence Family members of Dutch nationals in the event of illness, death or other special circumstances Healthcare workers - Seamen on duty Flight crew on duty.	All passengers must be in possession of the below in order to board the KLM flight: A negative PCR test < 24h <b>OR</b> a negative PCR test < 48h and a negative Antigen test < 24h. They must also complete a Health form prior to arrival.	Not required for the Netherlands	Passengers travelling from South Africa must quarantine for 10 days. This can be reduced to 5 days if a negative PCR test is obtained in the Netherlands. All passengers must complete a quarantine declaration form, including transit.

## **Health and safety on board**

Since the onset of the pandemic, Air France – KLM have adopted a series of measures to keep both passengers and crew as safe as possible.

- Wearing facial protection during boarding and flight is mandatory for Air France KLM
  passengers. Cabin crew will of course also wear facial protection. On Air France flights, surgical
  masks are mandatory. Cloth masks are not permitted.
- Our on board service is adapted to limit the contact between passengers and our cabin crew as much as possible.
- All our aircrafts are thoroughly cleaned and sanitized with approved disinfectants at least every 24 hours.
