- To qualify as Involuntary (INVOL) rerouting, disruption must have occurred within 48 hours prior to the scheduled departure time of the first
 impacted flight.
- Any disruption occurring earlier than 48 hours prior to scheduled departure time of first impacted flight will be considered as scheduled change (SKCHG). Please note that SKCHG may attract higher payout from partner airlines and therefore priority must be made to re-protect on available KQ options.
- To reduce the impact of revenue loss, EK sectors to be used in conjunction with KQ sectors via NBO-DXB v.v. unless absolutely necessary to bypass NBO hub.
- To reduce the impact of revenue loss, ET sectors to be used in conjunction with KQ sectors via NBO-ADD v.v. unless absolutely necessary to bypass NBO hub.
- A similar principle should be applied to all other airlines where effort must be made <u>not to bypass NBO</u> hub while re-protecting/re-routing pax, unless it's necessary.
- Only re-protect on operating flight numbers as per above list and not on marketed codeshare flights.
- Do Not re-protect on 4Z between NBO-JNB.
- Always use the Lowest available RBD and re-protect in the **SAME CABIN** as per original issue.
- Jambojet_Inside disruption window, check-in controllers to channel FIM to JM for rebooking. In case of schedule change (outside KQ disruption window) CEC will forward impacted passenger list to JM for rebooking.
