EMCT Enforcement of Minimum Connecting Time


We are pleased to announce that effective from 20 March 2023 we will be implementing the EMCT (Enforcement of Minimum Connecting Time) on all active and newly sold bookings on SAA and SAA Marketing flights.

The Minimum Connecting Time (MCT) is the time required for a passenger to connect from one flight to another at an airport.

The EMCT (Enforcement of Minimum Connecting Time) will detect the minimum connecting time between arrival and departure in a PNR. If the MCT is violated the system will warn the agent that the connecting segment will be cancelled by End Transaction. This will ensure that the agent takes the necessary steps as to avoid violation on the MCT.

Kindly take note that this warning does not prohibit the agent from End Transaction. However, it will UC the sector that is violating the connecting time.

EMCT (Enforcing of the Minimum Connecting Time) ensures that passengers / luggage will make their connecting flight thus enhancing passenger satisfaction. This will minimise the risk of NO SHOWS and Revenue Leakage.



Group bookings

For all the group bookings, the segment that is violating the connecting time will be UC before the booking is confirmed.
