Covid 19 Protocols

All travellers, entering and exiting South Africa may be required to complete and submit the prescribed health forms upon departure from and or re-entry into South Africa. World Leisure Holidays encourages all travellers to complete the forms 24 hours prior to travel. Please see the below link for latest information and the required forms: www.airports.co.za

Travelling out of SA:

If you are planning to travel, please check with the authorities of the country/ies you intend to visit for the latest travel regulations and any requirements which may apply to you. Also bear in mind that some information may have been updated since you made your travel arrangements.

Before bags are packed, please take a moment to review the below mandatory entry requirements ensuring you have dotted all your i's and crossed all your t's:

- All travelers over the age of 18 years will need to provide proof of vaccination status. Guests may travel 15 days after the second Pfizer vaccine and 29 days after the Johnson and Johnson.
- COVID-19 travel insurance (Mauritian citizens are exempt), if you have not secured insurance, World Leisure Holidays can assist with this, entry to Mauritius will be denied should you not have insurance in place.
- All travellers are required to complete their details on the attached link 72 hours prior to travel: safemauritius.govmu.org/
- All clients will undergo an antigen test on arrival at the hotel.

All clients travelling to the Maldives, please ensure that the online traveller declaration is completed prior to departure from South Africa.

All clients travelling to the Seychelles, please ensure that the online traveller declaration is completed prior to departure from South Africa.

All clients travelling to Zanzibar, please take note of the following requirements:

- 24 hours before arrival please complete the traveller health form on healthtravelzanz.mohz.go.tz.
- A negative PCR test for entry to Zanzibar will be required.
- Clients arriving from the high risk areas (South Africa is currently one of the high risk countries), will need to do an antigen test on arrival at the airport. The test will be for the clients own cost with of approximately USD 25 per person.

Travelling into SA:

Passengers travelling to South Africa are advised to carry a printed medical certificate for a negative COVID-19 PCR test result (within 72 hours of departure) or proof of full vaccination status. Children under the age of 5 years are exempt from PCR tests.

Passengers will be screened on arrival in South Africa. Those presenting with symptoms of COVID-19 must quarantine until a repeat test is conducted. Both the quarantine and the test are for passengers' own account.
