REMINDER transit / transferring in ISRAEL.

Below conditions and the actions:

- 1. Minimum MCT in TLV is 3hours and maximum 24hours.
- 2. Transit passengers will hold a combined ticket for both flights or two separate tickets.
- 3. Passengers must go through check in and hold a boarding pass for the onward flight from Tel Aviv.
- 4. The connecting flight from terminal 3 only in TLV .5. If there is baggage to send, it must be tagged to the final destination.
- 6. It is mandatory to check the passenger's travel documents for entry to the final destination.
